We are certified to the Sustainable Forestry Initiative ®, Inc. Forest Management Standard and believe in environmentally responsible forest management. As active supporters of the community, we are committed to making our neighbors aware and understanding of the scope of upcoming management activities.

This letter is to inform you that we have scheduled a pre-commercial thinning operation near or adjacent to your property. Pre-commercial thinning is the cutting of small trees which are overcrowding young forests. This improves forest health by allowing the cut stems to cycle back into the forest floor. We welcome your questions or concerns. However, no response is necessary. This operation is scheduled to begin sometime in the year 2019. The location is identified by the following legal description:

Section 14 Township 6 North, Range 10 West Approximately 95 Acres

Forestry operations can be interesting to observe, but it is important to keep a safe distance at all times. Please take the appropriate precautions so that neither people nor pets venture into active operation areas.



Feedback/Please Describe Your Experience: Woke up this morning to find 2 female adult elk bedded down in our front yard amongst the Mexican Feather Grasses. No harm done to the grasses — they sprung back when the elk moved on, and the elk don't find them palatable. They did find my ajuga quite tasty though. This is the third time that I've seen elk munch on the ajuga on their way by. Ajuga are listed as deer resistant, but clearly the elk find them to their liking. Given the vigorous nature of ajuga, I expect that the ajuga will recover come spring. The herd had largely moved northward by the time we saw them. The last stragglers made it past us by about 9am. Given their proximity to our house and our route, we just had to delay our doggie walk by a bit until they moved on. As for our other landscaping — the elk showed no interest in the Rhodies, ferns, common rush, euphorbia, miscanthus, wooly thyrme or Chinese fountain grasses. Each morning when walking the dog on a leash when still dark, I found myself cautiously searching with a flashlight to make sure I will not encounter the Elk. Finally, on our visit we were surprised at the filth, the extreme amount of Elk poop that we encountered everywhere on the sidewalks and streets. Even with the extremely heavy rains Saturday and Saturday night 12/29/17 it was not enough to clean it from the street and sidewalks. The amount of poop in the most trafficked areas appears to be more than on our last visit in early December. The city of Gearhart may consider cleaning the streets and sidewalks more frequently. I was escorting the elk off of the golf course on Sunday night at 5:15 trying to protect the greens from being trampled. As I finally gathered the elk to about 5th street on the golf course side of cottage, a cow elk turned back at me and charged me running full tilt. I was on a quad motorcycle, and couldn't get away fast enough. I was sure she was going to get me. I had the guad going full blast away and she was gaining on me. Luckily for me she stopped, I was threaten by them at least 3 times last evening while try to walk them off the course.

The elk are no longer afraid of anything we do anymore, they know this "shoo away from here" game, and are aggressive winners of that game. This has happened to most of my staff at one time or another over this last season. The elk herd is growing to the size that they are no longer intimidated or shy as they used to be, when elk numbers were smaller. Be aware that they could possibly attack at anytime you are in close proximity to them.

Re: Estuary Riparian Zone

I am writing this letter because of my concern for the protection of the vegetation and wildlife habitat of the area that borders the Necanicum Estuary. As I am sure you are all aware, portions of this area have been significantly changed in recent months, including illegal tree removal on the bank edge of the estuary.

City zoning laws include a 50 foot riparian protection zone for vegetation. It was brought to my attention by Chad and the Mayor that this does not include the Estuary riparian area. Despite several references in the Gearhart Comprehensive Plan regarding a 50 foot from the high water line protection zone, this cannot be enforced because it is not stated in a zoning ordinance according to them.

I am requesting that an ordinance be adopted, based on the mandate in the Comp Plan, for an Estuary buffer zone. I would urge a quick response on this matter, as the destruction will continue in that area.
