Subject - New Business - Adopt Budget Calendar

Synopsis - The Oregon Department of Revenue recommends that the city prepare a budget calendar. The calendar maps out all the steps that must occur to legally adopt a budget. It allows you to plan enough time so that the budget is adopted by June 30. The budget calendar is attached.

This year staff has scheduled all notices and meetings to accommodate the council's request to not adopt the budget using the emergency clause. This year the budget ordinances will be read once on May 1st, 2019, and we'll need to hold a special council meeting on May 29th, 2019 for the second reading. The reason for the special council meeting is to accommodate the 30 days required for the ordinance to become effective.

Council Options:

- 1) Make a motion that the to approve the budget calendar.
- 2) Make changes to the budget calendar and motion to approve.
- 3) Do nothing.

Recommendation: Staff recommends the council approve the budget calendar.
