

### **Staff Report**

### Subject - New Business - Adopt Budget Calendar

**Synopsis**: The Oregon Department of Revenue recommends that the City prepare a budget calendar. The calendar maps out all of the steps that must occur to legally adopt a budget and allows you to plan for enough time to successfully adopt the budget by June 30th. Staff has scheduled all notices and meetings to accommodate the Council's request to not adopt the budget using the emergency clause. Additionally, the budget will be approved via resolution instead of adopting through ordinance.

# **Council Options:**

- 1) Make a motion to approve the budget calendar;
- 2) Make changes to the budget calendar and motion to approve as amended;
- 3) Do nothing.

**Recommendation:** Staff recommends the Council approve the budget calendar. Using resolutions versus ordinances to approve the budget will save time. Ordinances require a meeting to read once by title only, and an additional meeting for the second title only reading. Both meetings have to be held prior to June 1st to ensure all ordinances take effect 30 days prior to the new fiscal year July 1st. Adopting by resolution happens with only one meeting and takes effect immediately.
