# **IMPOSING THE TAX**

BE IT RESOLVED that the following ad valorem property taxes are hereby imposed for tax year 2023-2024 upon the assessed value of all taxable property within the City of Gearhart:

- (1) In the rate of \$1.0053 per \$1,000 of assessed value for permanent tax rate;
- (2) In the amount of \$686,000 for debt service for general obligation bonds;

# **CATEGORIZING THE TAX**

BE IT RESOLVED that the taxes imposed are hereby categorized for purposes of Article XI, Section 11b as:

#### **General Government Limitation**

Permanent Rate Tax......\$1.0053 per \$1,000

### **Excluded from Limitation**

General Obligation Bond Debt Service......\$686,000
