Commissioner Reports: Cockrum talked about and passed out booklets to help people create a family emergency action plan. The booklets are available through CERT.


Visitors Comments: None.

File #24-03 Naming Private Road (in front of tax lot 61003CD00701). The Planning Commission recommended to the City Council that the subject road be named McAdam Court.

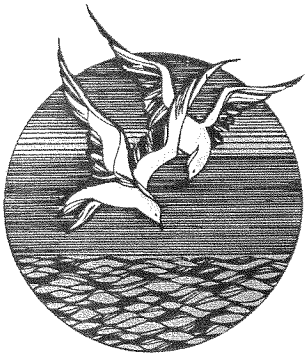
Concerns of the Commission: None
