Subject - New Business - Request for Funds - Police Vehicle Rifle Mounts

Synopsis: Chief Gregory is requesting reserve funds up to \$3,500 to purchase and install rifle mounts in the department's three patrol vehicles. The Chief has selected Day Wireless as the vendor because the product meets the departments specific needs, and the cost is under \$10,000, allowing him to choose a vendor without soliciting additional bids according to Oregon purchasing laws. Day Wireless will perform the installation on-site in Gearhart to minimize expense and vehicle downtime.

Recommended Motion: Staff recommends Council motion to approve the Chief's request for reserve funds up to \$3,500 to purchase and install a rifle mount in each patrol vehicle.

Legal Analysis: The Chief is in compliance with Oregon purchasing laws, which allow for vendor selection without multiple quotes when the cost is under \$10,000. Day Wireless has been chosen based on product suitability and cost efficiency.

Financial Analysis: There is currently \$28,045 available in the police car reserve fund.
