

For City Council Meeting - 2/5/2025

Subject - New Business - OLCC License Renewals

**Synopsis**: Attached is the list of OLCC liquor licenses in Gearhart that are eligible for license renewal. Current licenses are set to expire effective 3/31/2025. ORS 471.166 establishes the process for local governments to make recommendations to the OLCC. A list of reasons for unfavorable recommendation is also attached.

## **Council Options:**

- 1) Take no action. After 3/31/2025, the OLCC will process the renewal application as a favorable recommendation;
- 2) Provide a written, unfavorable recommendation to the OLCC <u>by 3/1/2025</u> requesting restriction for any / all of the licenses on the attached list that meet the unfavorable criteria;
- 3) Provide a written, unfavorable recommendation to the OLCC <u>by 3/1/2025</u> requesting denial for any / all of the licenses on the attached list that meet the unfavorable criteria.

**Recommendation:** Staff recommends Council take no action as nothing meeting the criteria for an unfavorable recommendation has been documented for any of the listed businesses.

**Legal Analysis:** Changes were made to the OLCC's liquor license application process effective January 1, 2023 where an applicant needs local government recommendation in order to proceed with the OLCC portion. In order to do this, the City implemented Ordinance #936 for process and Resolution #975 for fees. Renewals were sent a letter advising of today's recommendations, and the need to return the City renewal application and fee prior to the expiration date of 3/31/2025.

**Financial Analysis:** There is \$0 cost to renew with the OLCC though they do require a renewal application due well before expiration. The renewal license fee for the City of Gearhart due with our application is \$35.

## REASONS WE MAY DENY OR RESTRICT A LICENSE ORS 471.313(4)(5), OAR 845-005-0320, 845-005-0321, 845-005-0322 845-005-0325, 845-005-0326(4)(5) or 845-005-0355

The following is a list of problems relating to the **APPLICANT** or **BUSINESS** that OLCC *can* consider to refuse or restrict a license:

- 1. Applicant has a habit of using alcohol or drugs to excess
- 2. Applicant makes a false statement to OLCC (must be related to a refusal basis)
- 3. Applicant has been convicted of local, state or federal laws that are substantially related to the fitness of holding a liquor license
- 4. Applicant has demonstrated poor moral character
- 5. Applicant has a poor record of compliance when previously licensed by OLCC
- 6. Applicant is not the legitimate owner of the business
- 7. The business has a history of serious and persistent problems at this location. The problems can include:
  - Obtrusive or excessive noise, music or sound vibrations
  - Public drunkenness
  - Fights or altercations
  - Harassment
  - Unlawful drug sales
  - Alcohol or related litter

OLCC is **not** able to consider the following issues when deciding to renew a liquor license:

- Lack of parking
- Increase in traffic
- Too many licenses in a specific area (saturation)
- Entertainment type nude dancing, gambling, live bands, etc.
- Increased noise
- Zoning issues

In order for an unfavorable recommendation from a local government to be valid, the grounds must be found in the license refusal bases of ORS 471.313(4), 471.313(5), OAR 845-005-0320, 845-005-0321, 845-005-0322, 845-005-0325 or 845-005-0326(4)(5) or the license restriction bases of OAR 845-005-0355, and must be supported by reliable factual information.
