#### Greetings 5M!

I was asked by Clatsop County to poll you all if any had a desire to be on the Public Safety Coordinating Council. If none of the mayors do, then the mayors need to vote for one of our councilors to be appointed. Essentially the state requires that counties have (1) mayor or councilor appointed by the cities on the PSCC. I've clarified with county that the mayors act as the cities for appointment purposes, so while an appointee can be a mayor or councilor, the appointment is made by the mayors voting as the cities.

So, they're giving first dibs to the Mayors, and if none of us want it, please forward to your councils to see if any of your members want to be on it. If we have multiple councilors wishing to serve.

The PSCC is mandated under ORS 423.560 and ORS 423.565 to:

- 1. At a minimum, develop and recommend to the Clatsop County Board of Commissioners, hereinafter referred to as Board of Commissioners, a comprehensive plan for the use of:
  - a) State resources to serve the local offender population;
- b) State and local resources to serve the needs of that part of the local offender population who are at least 15 years of age and less than 18 years of age, which plan must provide for coordination of community[1]wide services involving prevention, treatment, education, employment resources and intervention strategies
  - c) Coordinate local criminal justice policy among affected criminal justice entities.
- 2. At a minimum, the PSCC shall also:
- (a) Develop and recommend to the Board of Commissioners the plan for use of state resources to serve the local youth offender population. (b) Coordinate local juvenile justice policy among affected juvenile justice entities.
- (c) Develop and recommend to the Board of Commissioners a plan designed to prevent criminal involvement by youth. The plan must provide for coordination of community-wide services involving treatment, education, employment and intervention strategies aimed at crime prevention.
  - (d) Create a facility advisory subcommittee when provided with the information described in ORS 169.690.
- (e) Annually review any metal theft plan of action submitted to the council under ORS 165.127, and if appropriate, make written recommendations to the district attorney for plan improvements.

Please let me-know if anyone wants to serve! If not, reach out to your councilors-to see if they'd like to serve and then report back to us so we can vote on the one to appoint.
