QUESTIONS:

1. If we use a contractor as an estimator on our team, does that preclude them from proposing on the contractor RFP/RFP or bid?

ANSWER: No. If a contractor is part of the architectural team to provide cost estimating services, they will be allowed to propose or bid on any future procurements related to this project.

2. Regarding Item Q, Proposal Requirements, Part VI Fee Proposal – Do you require a full 'letter' fee proposal (inclusions, exclusions, assumptions etc.), or a brief narrative and table indicating our Phase 1 fees?

ANSWER: Revise RFP paragraph "V.Q.VI – Fee Proposal" as follows:

Submit a fee proposal for Phase I (all pre-bond work) based on the scope of work described in the RFP and Exhibit A. Include fees for subconsultants such as cost estimating, structural, and civil as necessary. Fee proposal section to include a narrative or list of assumptions, inclusions, and exclusions. A table showing the estimated level of effort and total cost for each trade is an acceptable format. Include a value for a reimbursable allowance. Provide hourly rates by applicable position for the duration of Phase I with anticipated future cost of living adjustments. Phase II (post-bond work) will be negotiated at the end of the Phase I.
