The regular meeting of the Gearhart Planning Commission for March 11, 2021 via teleconference was called to order at 6:05 pm by Vice-President David Smith due to an issue with President Dideum's computer.

## **CONSENT AGENDA**

On **MOTION** by Taggard, 2<sup>nd</sup> by Graff, the Consent Agenda was unanimously approved, approving the Minutes of January 14, 2021 and the financial reports of January 29, 2021 and February 26, 2021. There was no correspondence.

#### STAFF REPORTS

The Parks Advisory Committee is moving along with a master plan, the next step will be to review and compile the surveys and move along to a needs analysis. Connell expects the Parks Plan to get to the commission possibly by July.

The Highway 101 safety plan funded by ODOT is underway. There has been a stakeholders advisory meeting with several more meetings planned. There is an interesting new format with a virtual open house.

Final draft of the Buildable Lands Inventory is on your agenda for tonight at 7pm., a joint work session with the council to hear a presentation by Matt Hastie of Angelo Planning Group.

Connell forwarded Commissioners a solicitation for volunteers to serve on a statewide Citizen Involvement Committee.

There is an application in the works for a combined Partition and Conditional Use for 2 triplexes on the highway.
