## Minutes

The regular meeting of the Gearhart Planning Commission for Thursday, June 13, 2019 was called to order at 6:00 pm by president Virginia Dideum.

## STAFF REPORT

Connell reported the city council had their first hearing on the community resiliency amendments, council agreed to adopt with minor changes; more PR on the disclosure statement, clarify the flexible building options for bare land and new development. It will go back to the council on July 3<sup>rd</sup> for the first reading of the ordinance. Connell said we are good with regards to the grant. Meg Reed wants to extend the grant because there is approximately \$4500 left in the grant from engineering that did not get used and could be used to strengthen Pacific Way or provide new signage.

The application for the master parks plan is in and if granted the project would be a 1-year grant to start in October for \$15,000.

## COMMISSIONERS REPORT

Dideum said the Navy exercise at Camp Rilea was very enlightening and the biggest take away was in the case of an event it would be at least 2 weeks before there was any response.

Dideum noted there is an upcoming class on parliamentary procedure at Clatsop Community College from June 25<sup>th</sup> to July 23<sup>rd</sup>.


