AN ORDINANCE VACATING LINCOLN AVENUE, GEARHART HEIGHTS TRACTS, CITY OF GEARHART, CLATSOP COUNTY, OREGON.

WHEREAS, the Gearhart City Council, Gearhart, Oregon, initiated vacation proceedings pursuant to ORS 271.080 for vacation of Lincoln Avenue described on Exhibit A attached hereto and made a part hereof; and

WHEREAS, the City Council having found no reason existing why the vacation should not be allowed and the necessary notice having been posted on the subject real property and a formal hearing having been held at the hour of 7:00 p.m. on the 1<sup>st</sup> day September, 2004, in the City Hall Council Chambers, Gearhart, Clatsop County, Oregon; and

WHEREAS, due notice of the time and place of hearing was given as required by law; and

WHEREAS, the property owners of the abutting property have consented to the vacation; and

WHEREAS, the City Recorder has indicated that all City liens and taxes have been paid on the land covered by the vacation; and

WHEREAS, a formal hearing was held at the appointed time and place on the requested street vacation and with no objections having been received by the City Council; and

WHEREAS, it appears that it is in the best interests of the Public to allow the vacation of Lincoln Avenue in that the area does not need to be utilized for a public street or other public purposes and will allow for a utility easement.

NOW, THEREFORE, the City of Gearhart ordains as follows:

Section 1. The property in the City of Gearhart, Clatsop County, Oregon, more particularly described on Exhibit A attached hereto and made a part hereof, is hereby vacated and this vacation is hereby made a matter of public record and expressly changed of public record so as to indicate, as required by law, such vacation; it is further proved that the City of Gearhart shall file a certified copy of this ordinance with the County Clerk of Clatsop County, State of Oregon, and the County Assessor and County Surveyor of Clatsop County, Oregon. Nothing contained herein shall cause or require the removal or abandonment of any water main, conduit, pipe of any kind, including wires, poles or other things used or intended to be used for any public service and the right is hereby reserved to maintain, continue, repair, construct, renew, replace, rebuild and/or enlarge any and all such things now or hereafter in the future.
